**WAYNE COUNTY SMALL FRY RODEO - MINOR'S RELEASE, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT**

We the Undersigned, hereby request the above named minor (hereinafter referred to as "PARTICIPANT") be granted permission to: (1) enter the arena area, (2) participate as a contestant, bystander, official or otherwise in rodeo events, (3) compete for money, prizes, recognition or award (hereinafter collectively referred to as "PERMISSIVE ENTRY").

In consideration of PARTICIPANT'S PERMISSIVE ENTRY to enter into the arena area, which is the arena from which admission to the general public is restricted, which includes, but is not limited to the rodeo arena, competition area, chute, pens, adjacent walkways, concessions, and other appurtenances, we the Undersigned, on behalf of the PARTICIPANT and for ourselves, our personal representatives, our heirs, our next of kin, our spouses and our assigned, do hereby:

1. ACKNOWLEDGE that PARTICIPANT'S involvement in the above activities is a dangerous activity and that the participation in the activity, as either a contestant, an employee, or volunteer, exposes the participant to a substantial and serious risk of property damage, personal injury and/or death. The Undersigned expressly acknowledges that the PARTICIPANT'S involvement in the activities will involve such a hazard.
2. AGREE, being fully aware that PARTICIPANT'S participation in the activities will expose him/her to a substantial and serious risk of property damage and/or personal injury and/or death, hereby releases the rodeo committee, stock providers, arena operators or owners, and each of them, their officers, agents, and employees (hereinafter collectively referred to as "RELEASEES" from liability for any and all property damage, personal injuries, or other claims arising from or related to the PARTICIPANT'S participation in the activities or rodeo, including those that are known, foreseen and unforeseen, future or contingent.
3. AGREE to release RELEASEES from any and all claims and liability arising out of strict liability or ordinary negligence of RELEASEES or any other participant which causes the PARTICIPANT or the Undersigned injury, death, damages or property damages. We, the Undersigned, jointly, severally, and in common, covenant to hold RELEASEES harmless and to indemnify and defend RELEASEES from any and all claims, judgments, or expenses RELEASEES may incur arising out of or in any way related to the PARTICIPANT'S activities or presence in the arena area whether caused by the negligence of the RELEASEES or otherwise.
5. DECLARE, REPRESENT, AND WARRANT that the PARTICIPANT is covered by family health insurance or that the Undersigned will cover all medical and other related costs which the PARTICIPANT may require as a result of participating in the above described activities.

**BINDING EFFECT:** This Release shall be binding upon the Undersigned and the Undersigned's spouse, legal representative, heirs, successors, and assigns. This Release has been carefully and fully read by the Undersigned and the Undersigned fully understands it's terms and conditions and has voluntarily executed and delivered this Release on the date first written above
